

Road Strategy Implementation Plan



1. Introduction

This document is a schedule to the Road Strategy (the Strategy) and should be read in conjunction with that Strategy.

The Strategy has been developed with consideration to the linkages with a range of strategic documents, legislation, guidelines and standards relating to Council's provision of road network. It provides guiding principles and key strategic areas which influence all other plans, policies and strategies associated with the efficient and sustainable management of the road network within the Scenic Rim region.

2. Terms of this Implementation Plan

- i. This Implementation Plan will commence at its adoption by Council.
- ii. As a schedule to the Strategy, the purpose of this Implementation Plan is to provide guidance and timing of identified strategies within the Strategy document.
- iii. This Implementation Plan will cease when the overarching Road Strategy expires.
- iv. This Implementation Plan will be reviewed and updated annually. Each version will be given a new review and issue date.

3. Performance and Reporting Arrangements

Reporting on the delivery of the Implementation Plan will be undertaken using Council's Sycle program on a monthly basis. This Plan outlines specific requirements with regard to each of the strategies identified in the Strategic Priority Areas.

3.1. Reporting
