Executive Summary

The Treasurer, Minister for Employment and Industrial Relations and Minister for Aboriginal and Torres Strait Islander Partnerships has written to Council inviting consideration of whether a request is to be made for a special holiday in the Scenic Rim region in 2016.

At the Ordinary Meeting held on 29 July 2014, Council adopted the Chief Executive Officer's recommendation that "Council nominate the Monday of the Brisbane Royal Show, 10 August 2015, as a special holiday for the Scenic Rim region".

REPORT

As Minister responsible for the administration of the *Holidays Act 1983*, the Treasurer, Minister for Employment and Industrial Relations and Minister for Aboriginal and Torres Strait Islander Partnerships is empowered to appoint, upon request by the Chief Executive Officer of the local government for the district concerned, a special holiday within a district, whether it be a day, or the forenoon or afternoon of a day.

Holidays of this nature are usually appointed in respect of an annual agricultural, horticultural or industrial show or other event which would be of significance to a particular district.

Requests for the appointment of a special holiday for 2016 must be submitted no later than 4 September 2015. Notification of the appointment of the holiday will be published in the Queensland Government Gazette and a copy of the gazettal notice will be forwarded to Council.

Executive Summary

A report reviewing Council's progress in delivering the 2014/2015 Operational Plan for the period April to June 2015 has been prepared and is presented for Council's endorsement.

The 2014/2015 Operational Plan was adopted by Council at the Special Meeting held on 3 July 2014.

REPORT

The attached report was prepared as at 30 June 2015 to report on Council's progress towards the implementation of the 2014/2015 Operational Plan.
