#### 7.1 Review of Divisional Boundaries

#### **Executive Summary**

It is recommended that a proposal to request the Minister to make voluntary changes to the region's divisional boundaries be endorsed for community consultation.

#### **Previous Council Considerations / Resolutions**

Not applicable.

#### **REPORT**

In accordance with provisions of the *Local Government Act 2009*, the divisional boundaries of local governments are determined by the Minister on recommendation of the Local Government Change Commission. Recent correspondence received from the Hon David Crisafulli, Minister for Local Government, Community Recovery and Resilience, reminded Council that in preparation for the 2016 quadrennial elections, each local government must, by 1 March 2015:

- a) advise the Minister and ECQ whether their divisions are within quota; and
- b) make any submissions for voluntary changes to their electoral arrangements.

For local governments with in excess of 10,000 enrolments, the enrolments within each division must not be more than 10% above or below the average for the local government area.

Statistics supplied by the Electoral Commission of Queensland (ECQ) show the enrolments for the region's six divisions as at 10 December 2014 were as follows:

These statistics confirm that:

- a) Enrolments of all divisions are growing but at differing rates:
- b) Division 2 enrolments currently exceed the 10% tolerance; and
- c) Division 5 enrolments are close to falling below the 10% tolerance.

Council has liaised with officers of the Electoral Commission of Queensland and Department of Local Government Community Recovery and Resilience regarding the process to bring divisional enrolments to within the 10% variance. Their recommendation is that Council submit a voluntary change proposal which has been prepared with some level of community consultation.

In order for Council to assess the extent of boundary changes required to achieve a more balanced level of divisional enrolments, ECQ has supplied enrolment statistics at Census Collector District level. Having reviewed that data it is recommended that for consultation purposes, Council propose the following changes:

- Transfer Area A (hatched on Attachment A) from Division 2 to Division 1 (This area comprises all of Division 2 on the eastern side of Tamborine Mountain north of Golf Course Road.);
- 2. Transfer Area B (hatched on Attachment B) from Division 6 to Division 5 (This area comprises that part of Division 6 within the area bounded by Red Bridge Road, Pocock Road, Hoya Road, Coronation Drive and Boonah-Fassifern Road.); and
- 3. Transfer Area C (as hatched on Attachment C) from Division 6 to Division 5 (This area is bounded Old Rifle Range Road, Allandale Road, Church Street, Ley Street, Elliot Road and Ipswich-Boonah Road.).

It has also been noted that the western boundary of Division 3, as established in the 2008 Local Government Reform process, follows the following alignment:

- Mount Lindesay Highway from Beaudesert south to Kooralbyn Road;
- The interstate train line from Kooralbyn Road to Running Creek Road; and
- Mount Lindesay Highway from Running Creek Road to the NSW border.

For consistency it would be desirable to align that boundary to follow Mount Lindesay Highway for its entire length. Aerial photography indicates that the affected area (Area D on Attachment D) contains:

- 12 houses (currently in Division 3) in the section between Kooralbyn Road and the rail underpass at Innisplain; and
- 8 houses (currently in Division 5) in the section between the rail underpass at Innisplain and Rathdowney township

It is considered that moving this section of boundary from the railway to Mount Lindesay Highway would therefore result in a net transfer of about 8 enrolments from Division 3 to Division 5.

The net effect of the above on the 10 December 2014 enrolments would be as follows:

Whilst Council may submit a voluntary change proposal to the Minister, it is at the Minister's discretion whether to refer that proposal to the Local Government Change Commission.

Risks

Indistinct or inappropriate boundaries can result in frustration by voters and future Divisional Councillors when attending to needs of residents.

#### Conclusion

It is considered these proposed adjustments will address the current imbalances between divisional enrolments and improve the clarity of boundary alignments.

#### Consultation

The boundary change proposals have been developed with assistance and advice from the Department of Local Government, Community Recovery and Resilience and the Electoral Commission of Queensland.

Given the tight timeframe and limited scope of the proposed changes, community consultation is planned by Media Release and information displayed on Council's website. Documents outlining the proposal will also be made available for inspection at Council's Customer Service Centres.

#### **Chief Executive Officer's Recommendation**

#### That:


1. Council endorse for public consultation the proposed changes to the region's divisional boundaries as described in Attachments 1, 2 and 3 of this report;

2. Council consider the outcomes of the public consultation process at its February meeting and determine at that juncture whether to proceed with submission of the proposed changes (with or without amendment) for consideration by the Minister Local Government, Community Recovery and Resilience.




Attachment 1 - Area on eastern side of Tamborine Mountain proposed for transfer from Division 2 to Division 1




Attachment 2 - Area on northern side of Boonah proposed for transfer from Division 6 to Division 5
