Moved Cr McInnes, seconded Cr Stanfield, that:-


- 1. The Chief Executive Officer's recommendation be adopted.





Attachment 1 - Area on eastern side of Tamborine Mountain proposed for transfer from Division 2 to Division 1






Attachment 2 - Area on northern side of Boonah proposed for transfer from Division 6 to Division 5
