- (d) rating concessions; or
- (e) contracts proposed to be made by it; or

- (g) any action to be taken by the local government under the Planning Act, including deciding applications made to it under that Act; or
- (h) other business for which public discussion would be likely to prejudice the interests of local government or someone else, or enable a person to gain financial advantage.

8. MISCELLANEOUS BUSINESS

8.1 Summation of Recent Announcements

In response to a request from Cr McInnes for the Mayor to provide a summary of recent announcements, the Mayor referred to the following:

- The Government's recommitment to the construction of the Beaudesert Bypass, which will make a significant change to the flow of traffic within the central business district:
- The Vibrant and Active Towns and Villages Project which is about maintaining the look and feel that our residents enjoy whilst creating special environments;
- Council's asset strategies, including bridges, footpaths and drainage, which enable maintenance of assets and looking towards what can be achieved.
- Significant approvals such as Oaklands Estate;
- The Jobs Jump Start Program, ensuring we have future jobs for our community;
- The advocacy of the former Beaudesert Shire Council and the current Council, working with Ministers and State Government officers, culminating in the roll out of the \$30 million first development program to create jobs;
- The SCT plans for the creation of an inland port at Beaudesert on the interstate rail line and linking that to the inland rail project.

The Mayor reflected on the many programs and developments that make our region an area where people can "work, live and play".

He thanked the Councillors for their work with the community and congratulated the Chief Executive Officer and Council staff for their commitment and achievements throughout the year.
