APPLICATION TYPE

This form can be used for multiple application types in relation to Dog Registration. You must determine the purpose of your application which also determines the fee payable for the application. Please allow 14 days (subject to requests for information) for Council to decide an application. Only two dogs can be kept per property unless an animal keeping approval under the Local Law is held. All dogs over the age of 12 weeks must be registered, microchipped and the owner or responsible person of a dog must be 17 years or older. Council will NOT register restricted / prohibited breeds such as the American Pit Bull Terrier, Pit Bull Terrier, Dogo Argentino, Fila Brasileiro and Japanese Tosa, Perro de Presa Canario, Presa Canario. The registration period is 1 August to 31 July and an annual registration renewal notice will be issued during July detailing fees payable.

- New registration where dog/s are not currently registered and usually or proposed to be kept within the Scenic Rim region.
 Refer dog registration fee schedule. If registering dogs kept under an Animal Keeping approval (kennel) refer Dog Registration Kennel form.
- **Reciprocal registration** where dog/s are currently registered with another participating Queensland Local Government Authority and relocating to the Scenic Rim region (same applicant). No fee payable.
- Amendment / changed information where information relating to the dog or owner has changed. The dog must have a
 current registration and if transferring ownership of dog/s, you must obtain the current registration holders written consent.
 No fee payable.
