Warning: Risks associated with the Event

- 1. The Event is a physically demanding recreational activity, which involves a team of persons pulling a tractor 15 metres. In the case of the senior Event, 12 adults pull a 12-tonne tractor, and in the junior Event, 4 juniors pull a 1-tonne tractor.
- 2. Participation entails a risk of Injury and Damage being suffered by a Participant, and of consequential Damage being suffered by a Dependent.
- 3. There may be delays in a Participant receiving relevant emergency medical treatment.
- 4. Council recommends that a Participant seek advice from their medical service provider to ascertain the consequences to their medical health regarding any pre-existing medical or other conditions which may affect the risk of Injury or Damage that the Participant may suffer as a consequence of participating in the Event.

Disclaimer

- 5. Neither Council nor its Representatives accept responsibility at law for the safety, health or security of:
 - (a) the Participant participating in the Event;
 - (b) persons who might be consequentially affected if the Participant suffers Injury or Damage, e.g. a Dependent.

Voluntary assumption of risk

6. I have read, and I understand, the above warning and disclaimer.

For an adult Participant:

7. I understand that participation in the Event is not free of risk to me as a Participant.

Despite any risks, I voluntarily accept all risks of participating in the Event, and all risks of Injury and Damage that I may suffer as a direct or indirect consequence of participating in the Event.

For the parent/guardian of a Participant who is a child or lacking full legal capacity:

- 8. I understand that participation in the Event is not free of risk to the Participant or to myself as parent/guardian.
- 9. Despite any risks, I voluntarily consent to the Participant participating in the Event.
- 10. I voluntarily accept all risks of the Participant participating in the Event, and all risks of Injury and Damage that the Participant and I may suffer as a direct or indirect consequence of allowing the Participant to participate in the Event.

Acceptance and Consent

- 11. I acknowledge that Council relies on the information provided by me and state that all such information is accurate and complete.
- 12. I warrant that I am/the Participant is physically fit to participate in the Event and I have not been advised otherwise by a qualified medical service provider.
- 13. I agree that I/the Participant will follow the reasonable instructions of each of Council's Representatives when participating in the Event.
- 14. I consent to me/the Participant receiving any medical treatment (including ambulance transportation) that Council or its Representatives think required during the Event.

Release and Indemnity

- 15. I give the following release and indemnity in return for Council:
 - (a) allowing me to participate in the Event as a Participant;
 - (b) (if Participant is a child or lacking full legal capacity) allowing the Participant to participate in the Event; and in return for the Representatives:
 - (c) assisting me while I participate in the Event as a Participant;
 - (d) (if Participant is a child or lacking full legal capacity) assisting the Participant at my request (hereby made) while he/she participates in the Event.
- 16. I release and discharge Council and each of its Representatives from responsibility or liability to me for Injury and Damage that I or the Participant sustain, directly or indirectly:
 - (a) when, or as a consequence of, participating in the Event as a Participant;
 - (b) (if Participant is a child or lacking full legal capacity) as a consequence of the Participant suffering Injury or Damage when, or in consequence of, the Participant participating in the Event,

irrespective of how the Injury or Damage occurs.

- 17. I undertake to indemnify and hold harmless Council and each of its Representatives against all loss and expense incurred through being held liable to the Participant, to me, or to any Dependent of the Participant or of mine, because of Injury or Damage:
 - (a) that I suffer as a Participant; or
 - (b) (if the Participant is a child or lacking full legal capacity) that the Participant suffers,

where the Injury or Damage results directly or indirectly from:

- (c) my participation in the Event as a Participant;
- (d) (if Participant is a child or lacking full legal capacity) the Participant participating in the Event.
- 18. In this document:
 - (a) "Council" means Scenic Rim Regional Council.
 - (b) "Damage" means damage or loss.
 - (c) "Dependent" means a parent, guardian, spouse or dependent.
 - (d) "Event" means the tractor pulling competition which is part of Council's winter harvest festival, involving a senior competition (adults and children 16 years of age and above), and a junior competition (children between the ages of 10-15 years).
 - (e) "Injury" means illness, injury, adverse physical reaction, or death.

- (f) "Participant" means the person intending to participate in the Event named in this document as the Participant.
- (g) "Representative" means employee, contractor, and voluntary assistant.
