- Amendment to licence if you already hold the licence and intend on making alterations to the operation, eg changing processes, services, layout or structure/s.
- Transfer of licence only where you are taking over an existing licence. The premises must have a current licence, no changes to the operation must have occurred and you must obtain the current licence holders written consent.

Suitability of premises

Businesses providing *higher risk personal appearance services* need to ensure their premises comply with the building standards detailed in Part 5, MP 5.2 of the Queensland Development Code, refer to the website for the <u>building standards</u>. This standard applies to places of business where *higher risk personal appearance services* are provided to the public as part of a *business transaction* to minimise the risk of infection in a place of business where *higher risk personal appearance services* are provided.

Plan assessment/design requirements

Plans are required for any new premises where the activity has not been previously approved or where any alterations are proposed.

- One copy of all plans drawn to scale 1:100 or 1:200, with elevations and details no smaller than 1:50;
- All plans not larger than A3 and clearly legible to a draftsperson quality;
- Floor plan showing all fittings, fixtures and equipment eg location of hand basin;
- Site plan showing location of site relation to surrounding land uses;
- Technical reports and other information such as brochures or photos can be attached as necessary to accompany the plans eg bench surface material and finishes of walls, floors and ceilings.

Other approvals

Where your proposal involves new or altered structures etc, you may require planning, building and/or plumbing approval. It is your responsibility to ensure <u>all</u> relevant approvals are obtained. A licence under the *Public Health (Infection Control for Personal Appearance Services) Act 2003* does NOT constitute approval of other aspects of your operation.

Have you considered the following:

Tattoo Operator Licence businesses wanting to give tattoos also need a Tattoo Operator Licence from the Office of Fair Trading (OFT). You will need both the tattoo operator licence and Council's higher risk personal appearance services licence to operate. You are encouraged to apply for the tattoo operator licence first, saving you time and money in the case you are not eligible. Contact the Office of Fair Trading on 13 74 68 or visit website <u>Office of Fair Trading - Tattoo Operator Licence</u> to find out what is required.
Planning you will need to find out what your land use approvals are and if you require additional approval. Contact Council's Development Assessment and Engineering team to find out what is required.
Building you will require approvals for new buildings or changes to existing structures, tenancy fit outs, installation of cool or freezer rooms, installation of mechanical exhaust ventilation and a Certificate of Classification for the buildings/structures, etc. Contact Council's Building Services team or a private certifier to find out what is required.
Plumbing you will need to gain approval for any plumbing installations required for the skin penetration business. Contact Council's Plumbing Services team or a local plumber to find out what is required.
Trade waste you will need to obtain approval to release trade waste to the sewer and may have to install a great interceptor trap or similar which will require ongoing servicing. Contact Urban Utilities on 13 26 57 or visit website <u>www.urbanutilities.com.au</u> to find out what is required.
